Unit 1.2 Legal principles regulating persons with disabilities in the health field: Autonomy in decision-making: consent and prior instructions. The lack of autonomy in decision-making: consent by representation. The process of incapacitation and other legal guardianship processes.

Unit 1.3 Socio-health policies on dependency and disability: Socio-health needs related to disability and dependency. The social and health care system in Spain. The coordination and integration of care levels. Dependency assessment scales

Unit 1.4 Management of care resources in dependency and disability: Management models in social health centres. Person-centred comprehensive care. Patient safety. Coordination of the multidisciplinary team. Administrative and material resource management
