3. Justification in the curriculum, relation to other subjects and to the profession

International Trade and Financial Market considers an advanced analisys of International Economics. The subject looks into the main items about Trade and Financial Globalization. Special attention will be paid to recent changes in International Trade and new competitive strategies of nations, in particular, global value chains and offshoring strategies. In addition, regarding financial topics, we will focus on the main international macroeconomic relations, such as inflation, interest rates and exchange rates, the main theoretical determinants of international crisis and its real characteristics in recent years (Great Recession in US and Sovereign debt crisis of Eurozone).

Evaluation criteria for the final exam:

Continuous assessment:

It is based on the assessment of competences through various training activities (problem-solving, debates, complementary readings, questionnaires,...), active participation in class, and a final test. Attendance at seminars or other events programmed in the Faculty will also be positively assessed. According to the Student Evaluation Regulations, the student is required to obtain a mark of 4 in the final test to average the obtained scores in the rest of the proposed training.

Any case, the minimum overall grade necessary to pass the subject will be 5 points out of 10.

In case of plagiarisme in training activities, according to Compilatio program, such activities will have a failing grade.
