#### 3. Justification in the curriculum, relation to other subjects and to the profession

Humanities and Social Science studies require an understanding of the origin and development of contemporary ideas, values and conflicts. This subject aims to bring the student closer knowledge of the main philosophical, ethical and social movements, their conflicts and their relationship with current problems. We are witnessing the end of a cultural and social project rooted in the Enlightenment and the birth of a new culture and society where local spaces and values conflict with the global. The subject digs on the project of modernity that emerged in the seventeenth and eighteenth centuries, the development of its tensions and the socio-cultural world from which we have thought and felt, to which we still partially belong, but also aims to clarify how that system conflicts with an increasingly globalized world. For this reason, we will try to analyze what is new in that society, with its movements in favor and against, its contradictions and its perspectives.

We consider that the knowledge and understanding of the main philosophical, ethical and social current trends, the problems and conflicts from which they result, and also the solutions they propose, are essential elements in the integral formation of a graduate in Humanities, to succeed as a future social research or as a future teacher.

This subject is related to the History of Philosophy of the first year, History of Ethical and Political Thought of the third, Logic of the Argumentation of the fourth and with some points of Foundation of Social Anthropology.

Recognize the main today's world social and moral conflicts, analyze their causes and effects and judge them from ethical theories.

Reflect on the fundamental problems facing our era: unemployment, globalization, scientism, technologization, reification, media imposition, emptying of the sovereign subject, ecology, immigration, interculturalism, sexism, neoliberalism, racism and xenophobia ..., knowing the different answers that have been considered.

Relate Philosophy with Human and Social Sciences.

Achieve an overview of the main contributions of philosophy in the field of theory of knowledge, ethics and politics throughout history, relating them to the context in which they were raised, their differences and the repercussions they entail.

Capture the relationships between knowledge and power and the mythologies to which they give rise.

Grasp the ethical advantages of cosmopolitan and intercultural citizenship.

Explain orally or through written reports the results of reading rewiews, essays or short papers, in well-argued manner.

Other methods of assessment	80.00%	100.00%	Students could choose between two evaluation modalities. a) Written test: 60%, reviews, reports and readings: 10% and critical essays on short texts: 10% (Total: 80%) b) Research essay on one of the topics that the professor will propose at the beginning of the course, carried out under his or her tutoring, which must be defended. The fundamental criteria for evaluating the same will be the questions of knowledge about the topic addressed, quality of analysis, relationships, structure, clarity and coherence of the argumentation, examples, use of bibliographic resources and sources of new technologies, application of knowledge acquired throughout the course and conclusions: 60%. To this note will be added a 20% contributed by reviews, text comments, exhibitions and readings.

According to art. 4 of the UCLM Student Evaluation Regulations, it must be provided to students who cannot regularly attend face-to-face training activities the passing of the subject, having the right (art. 12.2) to be globally graded, in 2 annual calls per subject, an ordinary and an extraordinary one (evaluating 100% of the competences).

## Evaluation criteria for the final exam:

Continuous assessment:

Students will choose one of these two options:

- a) Directed work on one of the topics that the teacher will propose at the beginning of the course; this work will be carried out under his direction and tutoring and must be defended to the teacher and presented in a synthetic way in class. The fundamental criteria for evaluating the essay will be questions of knowledge, quality of analysis, links, structure, clarity and logical coherence and argumentation, examples, factual accuracy and reliability, and uses of bibliographic resources and sources of new technologies.
- b) Written test on the content of the theoretical classes and readings, in which the acquisition of philosophical knowledge will be evaluated with an adequate understanding, the ability to present and argue and the ability to apply the knowledge to various topics and problems In both cases, the option chosen will provide 60% of the grade.

Another 20% will be distributed among

- Reviews, reports and critical comments on the content of classes and readings, as well as other complementary activities (conferences, etc.), assessing the autonomy and ability of the student to apply philosophical knowledge to topics of social or scientific interest, their capacity for analysis, synthesis and argumentation.

Finally, the remaining 20% will be the result of participation in classes, in the discussions and in the review of the topics discussed in them. How to change from continuous to non-continuous evaluation: any student may change from one system to the other if he/she has not fulfilled up to a 50% of

the continuous evaluation tasks during the academic period. If a student has already fulfilled the 50% of the evaluable tasks, or if the lesson period has already finished, he/she will not be allowed to change the evaluation system.

#### Non-continuous evaluation:

In the non-continuous evaluation, the percentage that is assigned as "assessment of active participation" (20%), will be added to the value of 20% assigned to the delivery of reviews, reports, readings and critical comments. Apart from that, the criteria of continuous evaluation are maintained. How to change from continuous to non-continuous evaluation: any student may change from one system to the other if he/she has not fulfilled up to a 50% of the continuous evaluation tasks during the academic period. If a student has already fulfilled the 50% of the evaluable tasks, or if the lesson period has already finished, he/she will not be allowed to change the evaluation system.

#### Specifications for the resit/retake exam:
