According to art. 4 of the UCLM Student Evaluation Regulations, it must be provided to students who cannot regularly attend face-to-face training activities the passing of the subject, having the right (art. 12.2) to be globally graded, in 2 annual calls per subject, an ordinary and an extraordinary one (evaluating 100% of the competences).

## Evaluation criteria for the final exam:

#### Continuous assessment:

The final test includes two parts, both of the same weight. The first part of the final test may be carried out in the exam period of the ordinary call of the first semester. Students who do not pass this first part or do not take it, will have to take a final test that includes both parts in the ordinary call for the second semester. The rest of the evaluation criteria will only be considered when the student has passed this final test.

The final test will be passed when the student, both in the first part of the final test and in the second part (which, as already indicated, this second will be done with the entire subject or with the content of the second semester, if the first part has already been passed), you have obtained a minimum of four points out of ten.

As already indicated, the average grade of both parties will compute 70% of the final grade for the course, the other 30% of the final grade being the rest of the evaluable activities, provided that the final test has been passed. In case of not passing said final exam, the total grade for the course will only be the average grade for the final exam.

Those students who, although they have carried out evaluable activities, wish to be evaluated with the non-continuous evaluation criteria must inform the teachers before the end of the class period.

Regarding the evaluation in case of illness or other special circumstances (mitigating rules) see article 6 of the Regulation of Evaluation of the Student of the University of Castilla-La Mancha.

#### Non-continuous evaluation:

The evaluation will be carried out with a final test that will include the specific tests that are considered necessary to evaluate all the competences of the subject.

Those students who, although they have carried out evaluable activities, wish to be evaluated with the non-continuous evaluation criteria must inform the teachers before the end of the class period.
