"Competition Law and Industrial Property Rights" is divided up into two relevant parts of Commercial Law. It deals with the rules that aim to protect free competition and fair competition among undertakings in Spain. Likewise, industrial property regulations concerns both the so-called law of inventions (such as patents and utility models), and distinctive signs, such as trademarks and trade names. These are important tools of business activity that identify the undertakings and its products or services. The content of "Competition Law and Industrial Property Rights" is of a great importance, as the knowledge and competences acquired are likely to be used in the practical practice of business law and are also related to other disciplines such as Administrative Law, Civil Law and Procedural Law, among others.
