# Evaluation criteria for the final exam:

### Continuous assessment:

The final exam will consist of two parts: a partial exam that will take place in the evaluation period of the first semester (a mark over 5 is required to release the syllabus of this first semester) and a second test in the evaluation period of the second semester. The grade of the final exam will be added the grade obtained in the remaining evaluable activities when a minimum score of 4 out of 10 is obtained in the final exam.

#### Non-continuous evaluation:

The evaluation will be carried out with a final test that will include the specific tests that are considered necessary to evaluate all the competences.

## Specifications for the resit/retake exam:

In the extraordinary call, syllabus will be recovered through a final exam. The remedial evaluation of the competences acquired with training activities must be communicated to the professor before the beginning of the final evaluation period and will be carried out through specific tests that will be included in the final exam.

#### Specifications for the second resit / retake exam:

The evaluation will be carried out on a single written test with theoretical and practical questions; A minimum score of 5 out of 10 will be required to pass the course.
